# **President's Report**

Welcome to the 2016 Annual General Meeting for the Ottawa Valley Branch. The fiscal year ending December 31 2015 was again a busy one for the Association and the Branch. It included the continuing efforts to protect your benefits and to fight the rate increases for the Public Service Health Care Plan. The "Honour Your Promise" campaign is still alive for the future, and litigation regarding the increase is still being worked on.

A Federal Election year is always busy for our Association, and 2015 was no exception in this regard. With the government now being led by the Liberal party, there have been some indications of improvements for seniors and veterans in particular. Your Association will be watching these developments carefully to ensure the promised changes are carried out. I realize that not everyone will be in agreement with some of the policies being introduced by the new government, and that it will take time to evaluate the changes in style and in substance that the Liberal party is introducing. From an Association standpoint, we will continue to approach the government from a non-partisan standpoint, and focus on those issues that affect our members and seniors in general.

You are likely aware of the major changes within the organization that occurred at the 2016 National Annual Meeting of Members. The unexpected resignation of the CEO Sylvia Ceacero, followed by President Gary Oberg announcing that he would be stepping down a year early certainly caught many of us by surprise. Please be assured that the Association is in good hands with Debbie Bernhardt filling in at the National Office as Acting CEO while a search for a permanent CEO is in progress. Also, Ottawa District board director Konrad von Finkenstein has been appointed as Chair of the national Board, until a new President and Vice-President can be elected at the next Annual Meeting of Members.

The Branch governance changes required due to the new Canada Not-for-Profit Corporations Act and the new National bylaws will be presented later during this meeting. They include the new Branch bylaws, the repeal of our Benefits to Seniors Donations Policy document, and the redistribution of our Benefits to Seniors reserve fund. There could be other minor governance changes in the future, but these are the main issues that have to be addressed.

During 2015, it became obvious that the National reserve fund for emergency defence of benefits would be depleted by the ongoing fight to protect your PSHCP benefits at a reasonable cost. The National Office sent out a plea to all Branches to consider contributing Branch funds to the National Office, specifically to build up the National fund. After some deliberations, your branch executive decided to contribute \$5000 out of our reserves for this purpose. This money does not go into the general revenue for the National Office, and must be allocated to the National Emergency Defense of Benefits fund.

Our annual plea for new volunteers to contribute a little of their time and serve on our Branch Board of Directors is especially urgent this year. Most of your current Board members have been volunteering for many years, and I fully expect that we will have people stepping down this year, having served the Branch well. Without an executive to continue the work of the Branch, the Branch would cease to exist and would be absorbed into other neighboring Branches. The amount of work involved is not extensive, and we meet as an Executive about eight times a year. Executive meetings generally last about 2 hours. We plan for two general meeting a year currently, one being this meeting and the other a Fall social event, introduced 2 years ago. Skills involved are varied, and can include a basic knowledge of computer applications such as email, Microsoft Word or Excel. A general interest in federal politics, retiree benefits, senior's health, finance or quality of life issues for an aging population can also be particularly helpful to the Branch. Please consider coming forward as a volunteer to make sure the work of the Branch can continue. Also, if you know of other members who might be interested, please let them know of the current need.

Finally, I want to thank all the current Board members for their ongoing contributions to the Branch and to the membership. Without you the Branch could not be as successful as it has been for many years.

# Health Benefits Officer Report – Ed Rockburne

This last year has been representative of most years with a blend of inquiries regarding the Public Service Health Care Plan (PSHCP).

A major change which we will see on our pension checks this March is an increase of \$8.00 for singles and \$16.00 for families in the premiums for our PSHCP coverage. We can expect the Government to continue in its efforts to find new funding for Health care, as the Provinces seek increased transfers. In some Provinces they have brought about extra billing and user fees, which according to Louise Bergeron, in the Federal Retirees Health News Letter, is against the National Health Act of Canada. All this on top of changes to our Immigration Policy will put considerable drain on our Health resources and future costs.

Our membership is reminded that, when a spouse that has been paying the premiums for the PSHCP dies, the surviving spouse should, as soon as possible, make application to have the premiums paid by them. Otherwise they could face a three month qualifying period.
