Tell your representatives it's time to fix our elder care systems

The inadequacies of Canada's balkanized long term care system will be front and centre in Federal Retirees' meetings with Members of Parliament and MLAs over the coming months. Federal Retirees' urges all levels of government to collaborate on a comprehensive, national "seniors strategy" that includes national standards for home care and long-term care and an increased emphasis on the delivery of services in the home and in the community.

On August 13th, National President Jean-Guy Soulière sent an invitation to all members to *Tell your representatives we need national standards for long-term and home care!* That message included a template and eform to help you send letters to your MP and MLA. If you haven't already, why not take a moment to add your voice to the conversation? Help make sure reform to our long care system remains a top priority for our elected representatives. To find Jean-Guy's message, just go to www.federalretirees.ca.and enter "Tell your representatives" in the search bar.

Email address confirmations

Some of you will have received email messages from me at the end of August, asking you to confirm your email address. A few of you worried that the message you received was "phishing" for personal information. No, it really was just me.

When we send out updates using the national mass email messaging system, we get a number of "bounce backs" for a variety of reasons. Repeated bounce backs suggest that the address is no longer valid and those addresses go on a "blocked email" list. After we sent out Update #6 (August), the number of addresses on the "blocked" list was *concerning*, so we invested some time in checking, first by sending an email to each address in question from my home computer (*I had a free evening...*) 'Thank you' to the 100+ members who replied. And then, if we didn't get a response right away, we followed up by letter. So far we have been able to remove three quarters of the addresses from the "blocked" list (i.e. 150 of 200). Who says we don't know how to have fun? We will be holding our breath to see how many blocked email addresses are generated after we send out Update #7.

If ever in the future you find yourself thinking, "Haven't heard from Federal Retirees for a while..." please check with Steve to make sure the information in your profile is current and/or that your email address hasn't been blocked by mistake (or the magic of technology).
