A snap election challenges an advocacy organization to snap into action, and Federal Retirees is doing pretty well. The Association's priorities—national standards for Council of Senior Citizen Organizations of BC (COSCO) home care and long-term care, national pharmacare and a comprehensive seniors' strategy—are articulated on the national web-site under the title "British Columbia 2020 provincial election: Transforming care for seniors in BC". Branch volunteers have been able to take time out from the hunt for that tiny turkey to send letters putting those priorities to candidates (NDP, Liberals, Greens) in the thirteen provincial ridings that fall within Fraser Valley West's boundaries. And some of us (okay, me) have tried out the Letter to the Editor "tool" that

you can find on the national web-site. It's fun. Just enter your name and your postal code, and the tool will send your letter to the local papers in your area. You can use the template letter or modify it—keeping it tasteful and non-partisan, please. Check out the "sample" next page.

On October 16th, at 1 p.m. there will be a provincewide Town Hall with representatives from the major parties. The Town Hall is a collaboration between the and Federal Retirees. Kudos to Leslie Gaudette, Advocacy Program Officer, and the national office team for pulling this event together. If you don't receive an invitation by email, check the national web-site for directions on how to connect.

Eight days later, October 24th, you vote (please, please, please and thank you.).

Letter to the Editor (Sample)

Dear Editor:

We need British Columbia's next provincial government to act on the concerns of our seniors!

The well-being of older adults in British Columbia will depend on the commitment of the provincial government to work with the federal government to implement a national seniors strategy. There is urgent need for improvements in the quality of care in long-term care facilities and improvements in access to home care. All levels of government should work together to define standards of care and to make funding contingent on meeting those standards.

The COVID-19 pandemic exacerbated long-standing issues with the level and quality of care in long-term care homes. While the BC government has taken some steps to reduce the impact of this pandemic, more needs to be done to improve not only the quality of life of the residents, but the quality of life of their support workers and their unpaid caregivers. Long-term care residents deserve to be treated with dignity and compassion.

There is need for a comprehensive strategy to address the broader range of issues facing seniors. Quality care for the frail elderly is one essential element, as is reliable access to safe and appropriate prescription drugs. Seniors should be involved in developing plans to strengthen communities to combat social isolation. Such basics as income security, adequate housing and reliable transportation are social determinants of health for seniors and all Canadians.

As we enter the next phase of the pandemic, we will need to address additional health-care concerns, including the backlogs for surgical and medical procedures, the impact on mental health, and the social effects of restrictive measures put in place to stop the spread of the virus.

As British Columbians cast their ballots, we urge them to reflect upon what the parties and the local candidates have said about their plans to collaborate with seniors and with other levels of government to develop a comprehensive seniors strategy.
