### What do I need to do to join?

If you are paying into or receiving a federal pension, which would include members of the Canadian Armed Forces, the RCMP, the federal public service and retired federally appointed judges, or are a partner or survivor of someone mentioned above, you are eligible to join.

#### It's never been a better time to join

An annual single membership in 2020 costs only \$51.36 or just \$66.60 per couple. You can request a direct deduction at source from your monthly pension (DDS) or choose to pay by credit card or cheque.

For a limited time, you can take advantage of a one-time 25 per cent discount off annual membership fees by selecting the DDS payment method\*.

\*Unfortunately, this option is not available for current employees or those in receipt of judges' pensions or judges' survivor allowances.



- After many years of lobbying, a seniors' minister was named in 2018.
- Challenged the \$30 billion pension surplus grab in the public service superannuation accounts in 2011.
  - Fought to continue benefits for surviving spouses who remarry.

Helped defeat Bill C-27, a bill that put federal pension security at risk.

We will continue to challenge and contest all that puts our members and their pensions at risk. The more members we have, the stronger our influence will be.
