Membership

As of September 30, 2020, we have a total of 5,996 members in the Winnipeg and District Branch. This is a loss of 249 members since January 2020. Our organization is only as strong as our membership so, if you know of anyone eligible to join please encourage them to do so. If you refer a member, there are a couple of incentives that could be a benefit to you.

Branch Initiative

The first is the Branch has a recruitment initiative where we will send you a \$25 gift card for a new referral or \$15 gift card for a change from a single membership to a double membership. Simply send an email to the branch stating that you have referred a new member, give us their name, and tell us what store/retailer you would like the gift certificate from.

National Initiative

The **Mega Recruitment Drive** (MRD) is now live, and it's **bigger and better** than any recruitment campaign we've ever done. For the second year running, all Federal Retirees members have the chance

to win several great prizes by recruiting new members to the Association.

This year's grand prize is **\$10,000 cash**, courtesy of Johnson Home and Auto. Secondary prizes include a **\$5,000 trip**, courtesy of Collette, one of two **Samsung tablets**, valued at \$350 each, courtesy of SimplyConnect, and one of five **\$100 prepaid AMEX cards**.

From Sept. 1 to Dec. 31, all members who successfully recruit a new member will receive a \$5 coffee card for each recruit and will be entered into the draw for the prizes above. **There are no limits to the number of ballots/coffee cards you can receive**, so the more people you refer, the more chances you'll have to win! Note that this year only those whose referrals result in a membership receive a \$5 coffee card.

There are a few new prize categories this year as well, rewarding members that go above-and-beyond to refer and recruit prospective members. Even new members will have a chance to get in on the action! The new prizes and prize categories this year are:

- **\$500 pre-paid credit card** for the most new members recruited, courtesy of Arbor Memorial
- \$250 pre-paid credit card for the most valid referrals, courtesy of Arbor Memorial
- **\$250 pre-paid credit card** draw for new members who join by referral during the contest period, courtesy of Arbor Memorial

Remember, you don't have to be retired to join Federal Retirees. You can recruit anyone who is currently paying into or receiving a pension from Canada's public service, the RCMP or the Canadian Armed Forces. Federally appointed judges, honourably discharged non-pensioned veterans and anyone receiving a survivor benefit from the pensions mentioned above is also eligible for membership.

Our Facebook page has now reached 102 followers and 94 page likes. We continue to post valuable information relevant to our members regularly on Facebook, posting 76 posts in September 2020 and 60 in October 2020. Our posts reached 348 people in September, and 497 people in October. Our number of engagements (the number of times people have liked, commented, or shared our posts) in September was 570, and 431 in October.

Advocacy

Reach 338

The Winnipeg and District Branch is working with representatives from National Office and our National Board of Directors to support the Reach 338 initiative. This is an initiative to contact all 338 Members of Parliament. Our Branch is focused on contacting five Members of Parliament to ensure a number of things such as:

- Promote awareness of our organization
- Ensure that our key messages are clearly understood
- Advocate on behalf of our members promoting our key pillars including
 - Pharmacare;
 - o Retirement Income Security;
 - National Senior Strategy; and
 - Veterans

National Preferred Partner Updates (2 featured)

Johnson Insurance (Medoc)

Lots has been happening with Johnson Insurance our Travel and Home Insurance partner. This year, they saw a record number of claims following the issuance of travel advisories by the Government of Canada. Many of our members were enjoying their time in the south or in Europe and beyond when the pandemic came upon us in a short period of time. Although there were some delays due to volume of claims, over \$15 million dollars in incurred costs were paid out to our members for trip interruption, trip cancellation and health related events. Since September, we have continued to have our regular coverage (excluding Covid related costs) through Johnson Insurance, while enjoying a premium holiday. Our premiums will start again in January 2021 for an 8-month period (January to August) and then we will be back on our regular Fall renewal schedule.

Some changes to our coverage that have been announced recently include:

COVID-19 Medical Coverage effective October 1st, 2020

- Effective October 1, 2020 **medical coverage** under your MEDOC policy will include COVID-19 for the remainder of 2020 and with your new MEDOC policy beginning January 1, 2021.
- Your MEDOC policy now provides medical coverage for travel to areas outside Canada where travel advisories due to COVID-19 may still be in place.

Trip Cancellation/Interruption/Delay benefits

• Trip Cancellation and Interruption coverage remains in place, and is currently available for COVID-19 related cancellations if your trip was booked **prior** to the travel advisories being issued. However, as of January 1, 2021, Trip Cancellation and Interruption coverage related to COVID-19 will not be available for any travel bookings made since the March 2020 travel advisories.

Other important features of MEDOC Travel Insurance

- Coverage for an unlimited number of trips for a duration of up to 40 consecutive days;
- Access to coverage regardless of age or health status;
- Trip disruption trip cancellation, interruption and delay insurance for multiple trips throughout the policy year;
- Medical emergencies up to \$10 million in emergency medical coverage per insured person, per year;
- Vehicle return eligible expenses to transport your car back home if you are unable to because of a medical emergency;
- Baggage protection loss, theft or damage to your baggage, or reimbursement for necessities you need to buy if your baggage is delayed;
- Coverage while travelling within Canada (great for me with a cottage in Ontario)
