By-laws 8.1.2 Agenda, Mandatory Business

At every Branch Annual Meeting, the Members assembled shall:

a) Approve a record of proceedings of the last Branch Annual Meeting and any Special Branch Meetings;

b) Receive a report from the President concerning the activities of the Branch board since the previous meeting and outlining the plans and priorities for the current and following year;

c) Receive the reviewed financial records for the previous financial year;

d) Receive the budget for the current year and forecast for the next fiscal year;

e) Give the Board of Directors the authority to appoint a reviewer for the current financial year. The auditor shall NOT be a member of the Branch board or executive;

f) Consider any proposals for amendment of the Branch by-laws, notice of which was included in the notice for the meeting.

g) Conduct elections for the Branch board;

h) Conduct other such business as may be properly brought before the meeting.

Virtual 'Meet and Chat': Enhanced Road Assessment—Driving after 80

We had a good turnout (*just one short of the quorum for a Branch Annual meeting!*) for the January 14th Zoom presentation by Joanne Bergman, an ICBC Road Safety and Community Co-ordinator. Joanne took us through what drivers should expect when there will be 80 candles on next year's cake: You will get a notice from the Superintendent of Motor Vehicles asking that you see your doctor and complete a Drivers Medical Exam form. You may then be required to take an "Enhanced Road Assessment". Joanne's presentation included a number of tips on what Driver Examiners are looking for when they administer the Enhanced Road Assessment test. Specifically, did you:

- Keep to the posted speed limits?
- Look into your blind spots before you changed lanes or turned?
- Apply the rules of the road for intersections?
- Make right and left turns correctly?
- Come to a complete stop at stop signs and red lights?
- Stay in your lane when turning?
- (Of course you did, because you always do!)



There is lots of excellent information on-line at <u>icbc.com</u>. The Tuning-Up-for-Drivers study guide may be particularly useful in helping your feel prepared (although there is no written component to the ERA).
