Ian Spence delivered the "Year in Review" report, touching on many of the challenges and achievements of a most unusual (we hope) year. With most regular activities cancelled or deferred, Branch finances were in surplus for the year, and the members approved motions accepting the reviewed Financial Statement for 2020, the allocations for 'reserves' for initiatives planned over the next three years, and the budget proposed for 2021. Members also approved motions appointing the executive officers (president, vice -president, secretary and treasurer) as financial signing authorities and giving the board authority to appoint a financial reviewer for 2021.

Advocacy—Current campaigns

Long Term Care campaign – the FEDERAL RETIREES special campaign for long term care and home care is ongoing with emphasis on national standards. The situation with our Public Service Pension Plan owning Revera (a for-profit LTC service provider) is being monitored closely by the National Advocacy Committee and the National Board of Directors. Virtual 'Meet and Chat' Personal Planning—Upcoming sessions

We are following up on the Personal Planning (Overview) workshop that was presented on March 10th, with three more in-depth sessions that look at important legal documents you may want to have in place to

- a) make sure your wishes are carried out if you are incapacitated and
- b) give your family and caregivers some confidence and comfort when they are called on to make decisions on your behalf.

Please join us for informative and lively presentations by Terry Wright, a volunteer facilitator with COSCO's Seniors' Health & Wellness Institute.

April 15 – Representation Agreements:

These legal and binding documents allow an individual to have someone else speak for them in health and personal care matters and routine financial affairs if they are incapable of speaking for themselves. There are two types of Representation Agreements in BC and we discuss the importance and differences of the two types of document, points to consider when appointing someone to be your Representative, their duties and responsibilities.

May 13 - **Power of Attorney**: There are four types of Power of Attorney in BC, most people are familiar with only one. In this workshop, we discuss all four types. We also consider when you need a Power of Attorney, the steps you should take to consider who to appoint as your Attorney, the duties of your Attorney, problems with having a Power of Attorney and how to change your Attorney if needed.

May 20 - **Advance Directive**: Many seniors in BC are not familiar with what this legal document is and is not. In this workshop, we discuss what a person should do to prepare to create an Advance Directive, when a person should have an Advance Directive, what it is and what it is not, when it can be used and when it may be ignored.

Advocacy (cont'd)

New campaigns in February 2021

Responding 'nimbly' to unfolding events, National Office very quickly put together two campaigns that were launched through emails from our National President, Jean-Guy Soulière.

FEDERAL RETIREES made six key recommendations for budget priorities:

1. **Reform older adult care** by implementing a national seniors strategy, which includes national standards tied to funding for long-term care and home and community care, and investments to expand home and community care and address the social determinants of health.

2. Improve financial supports and investments in tools and programs to assist informal caregivers.

3. Move forward with implementing a national pharmacare program so that all Canadians have access to the medications they need.

4. Ensure long-term **retirement income security for** low-income seniors who qualify for Old Age Security and the Guaranteed Income Supplement.

5. Address gaps in direct funding programs for those whose income has been affected by COVID-19.

6. Protect pensions over the long-term by creating a strong policy environment that encourages innovation and makes defined benefit plans more readily available to Canadians.

· Support for Bill C213 on pharmacare

FEDERAL RETIREES supported this Bill as it was well aligned with our position on Pharmacare, calling on members to join in a letter writing campaign to MPs. Despite efforts by Federal Retirees and many other retiree, labour and health organizations the Bill was defeated with the NDP and Green Party members voting for and nearly all Liberal, Conservative and Bloc MPs voting against. This may well reflect very strong lobbying by pharmaceutical and insurance industries. The importance of this issue for our members is underscored by the fact that they sent up to 5,000 letters in 24 hours.
