- Reports:
 - o President successful year operated, good review from operators
 - Countless Zoom meetings with ministers incl TB and Seniors, MPs from all parties. No indication of benefits attack, but ...
 - SAGE all in-house (cheaper) and got the grant. Want to get rid of separate branch web sites.
 - Decided a few years ago to transition to a federal national not-for-profit structure, still some branch resistance.
 - o CEO Anthony Pizzino has just started in the position short statement
- Elections
 - o Three candidates for Ontario District (one slot), two for Vice-President
- Financial
 - o **2020**
 - Revenues over expenses \$1.5M more in the black (AMM would have been 0.5M, BOD on-line meetings saved \$200K)
 - BUT membership and membership fees down (600K below budget, \$260K below 2019)
 - AND Admin fee revenue \$400K below 2019 (to \$1M)
 - Note DBF up \$160K to 941K (target \$5M); new reserve \$430K Periodical Fund Grant Contingency (~2yrs SAGE Rev)
 - o 2021 Budget and 2022 Projection
 - Dues flat in 2021 and then up a bit to \$7M
 - \$80K in Branch supplementary funding
 - Admin fee revenue down 10% to 936K
 - Leasing revenue down
 - AMM and Board costs up from 2020 for 2022
 - IT costs DOUBLE from 2019
- Town Hall (second June Session)
 - o Will focus on Reserves. Not sure what will happen recommendations seem to mostly more talk
