Presidents Report - Summer 2015

This past year has been a busy and productive one for our Branch as last year at this time we were in the middle of our "Honour Your Promise" campaign to which our members responded with such enthusiasm. Unfortunately, the Federal government carried on with their plans to change the subsidy of our PSHCP effective April 1st of this year. I would remind you that if you are in receipt of the Old Age Pension and the Guaranteed Income Supplement, there is a form available for you to apply for a reduction in your premiums. In the meantime, our National office is seeking to legally force the government to return to favorable rates for all of us. Another major issue for our Branch in particular was the decision at the 2014 National AGM last June to require each of the six branches across Canada who had Incorporated to change that status to conform with all of the other Branches. At our General meetings throughout the past year, we have kept our members up to date on the necessary steps we needed to take to dissolve the Corporation and resume carrying on as a Branch under the aegis of the national Corporation. This required a re-writing of our By-Laws in which we were assisted by Deborah Krause at a Regional Meeting held in Airdrie last October. Gerry Thompson, our Past President, continues to work on finalizing our new By-Laws which we will present at our September 25th General Meeting for discussion and, hopefully, your approval.

You may have noticed that we have changed our name from Federal Superannuates National Association to National Association of Federal Retirees, a decision made at the National AGM last June in Montreal. Along with that, our popular "On Guard" newspaper became the new and shiny "Sage" magazine and our familiar logo has developed a rainbow of colors.

In addition, Anne Prusakowski is being assisted by Ursula Thorn in updating our own local website while our National website is also being updated. Therefore, some members of our Board, Willma Haney, Gabrielle Simpson, and Anne Prusakowski attended an IT Training Session in Airdrie on November 7, 2014 to learn how to operate the new "Walk Me" system which has been developed by our National Office to improve Relationship Management for all of our members across Canada. This training was supplemented by Web Casts which were available to all members of our Board who wished to participate. Also, a Web Cast was recently provided to update us on the Strategic Plan which was initially introduced at the 2012 National AGM held in Edmonton.

Our own General Meetings and Luncheons, always diligently organized by Lois Fisch with attention to every little detail, is where we have attempted to provide a platform for some of our Affinity Partners to make presentations so, on September 19, 2014, we featured Shelley Wark-Martyn who was responsible for Business Development Planning and Training for Chartwell Homes where NAFR members receive a discount if they decide to move in.

Supporting Veterans programs is a major priority for us and on November 11th, members of our Board were again present at the Military Museum in Calgary to lay a wreath on behalf of our members. We also make an annual donation to the Poppy Fund and we encourage members to bring food donations to our General Meetings for the Veterans Food Bank. In keeping with remembering veterans, on November 21, 2014, our featured speaker was Retired Warrant Officer Tex Leugner speaking on behalf of the Wounded Warriors organization.

Our Foothills Satellite Branch in Okotoks set an example for us to follow by inviting Monica Kilburn-Smith and Judy Butler to speak on the availability of Spiritual Care in the Hospice Society as well as Caroline Hart from the Calgary Co-operative Memorial Society. Since Gerry Thompson and I endeavor to support the work of our Satellite Branches, I was privileged to hear them speak and recommended them for our General Membership meeting and luncheon for February 20, 2015. We are grateful to Heather Thompson for her continuing support of the Canmore Satellite Branch and for her monitoring of Health in the News for us. Heather's husband, Gordon Thompson, had been a valued member of our Board but he moved on to the National Finance Board and we can only thank him for his advice and support while we had the benefit of his knowledge.

It is with regret, that we need to part with our popular and long-time Treasurer, Dennis Day. He and his wife, Dianne, have been dedicated workers on behalf of our Branch in everything we undertook to do. He will be missed by our Board as he kept us on a sensible and responsible track with all of our financial planning. They will also be missed by our members coming to General Meetings and luncheons as they cheerfully checked everyone in at the door and supervised the 50/50 draws. For the sake of his health, Dennis is being forced to retire and we want to wish him and Dianne a happy and healthy future.

We are grateful to our Auditor, Rob Pollard, for stepping up and agreeing to become Treasurer for the coming year and to our former Auditor, Sateen Katarey, for stepping in to help with preparing our financial records. We are also grateful to our First Vice President, Steve Harbicht, for his help and advice when problems arise and to Pat Henderson for her continuing work of trying to convince all members to pay their dues through DDS.

We are immensely grateful to all of our volunteers who come into the office on a regular basis. We could not operate without you. Rob Malcolm and Sally Manchurak are busy planning a special recognition luncheon for all volunteers in November of 2015. In the meantime, we are planning another Volunteer Training Session in September of 2015. The last such training session was held in 2013 so we need to keep everyone on track with the duties we, as one of the largest Branches in the country, are responsible for.

We do expect another busy year ahead as we complete the dissolution of our status as an Incorporated Branch and continue providing service to our members as we return to operating in the same manner as all other Branches in our National Association. Personally, I feel honored to have the privilege of being President of this Branch and to be able to work with such a co-operative and caring Board of Directors. Thank you for that privilege.

Notice of Special General Meetings - Calgary and District Branch

Two Special General Meetings are being scheduled to coincide with our fall and winter quarterly Luncheons on Sept 25, 2015 and November 20, 2015 respectively.

As we have been discussing with members the past six months, our Branch is taking steps to comply with a resolution passed at the National Association's Annual Meeting in June 2014. It requires the current six incorporated Branches to dissolve their corporate status and return to their Branch Charter status. We are one of the six incorporated Branches.

FSNA Calgary Branch was founded on December 31, 1964 when it was awarded a charter by the National Association. In 2007 our Branch became incorporated under the Alberta Societies Act. The intent was to allow the Branch greater flexibility to raise and/or borrow money to pursue the acquisition of a property to house our office and administrative records.

To proceed with returning to our charter status and dissolving our corporate status we will be asking members to vote on a series of motions at the September and November Special General meetings.

The purpose of the September meeting will be to pass a special resolution that will reactivate the original charter with a revised Branch name (National Association of Federal Retirees –Calgary and District Branch) and to function as an unincorporated part of the Association. Members will also be asked to pass a special resolution that will result in the adoption of new by-laws, and normal resolutions to elect/appoint a Board of Directors, and authorize funding transfers from the current corporate bank accounts to the new Branch unincorporated bank accounts.

The November meeting will deal with special resolutions to dissolve and wind down the corporation.

The intent is to make this a seamless transition so that members will not see any impact on their membership and benefits either nationally or at the Branch level.

How good pensions help keep your community afloat: Mayers

According to a study by the Boston Consulting Group : « Good pension plans support more than the people receiving the money. They support their neighbour and their communities in a big way [...]. The money they are paid is a huge economic energizer in the community where they live. The money they spend on groceries and restaurants, at the hardware store or taking yoga and fitness classes is greasing the local wheels." A few of the study's findings:

- In 2012, Canadian defined benefit plans paid out \$72 billion to 3.5 million pensioners.
- Most of this money is spent where they live.

• In Ontario, 7 per cent of all income in our towns and cities, or \$27 billion, is derived from defined benefit pensions.

• That \$27 billion generated \$3 billion in federal and provincial income tax, \$2 billion in sales taxes and \$1 billion in property tax on an annual basis.

• Seniors with defined benefit plans are confident consumers because the predictable income stream allows them to better plan their affairs.

• Defined benefit plans offer a broader social benefit, because people who get them rely less on benefits like the Guaranteed Income Supplement (GIS) to the tune of \$2 to \$3 billion a year.
