Presidents Report - Fall 2015

I will bring it to the September 25th luncheon at Fort Calgary for all to see and admire before placing it on display in our office. To me, this trophy signifies that ours is the best Branch in all of Canada. Of course, we all knew that but it is nice to have it acknowledged in such a meaningful way.

We were shocked and disappointed during the discussion period at the AMM to hear Gary Oberg, whom you will recall having been our featured speaker at our Annual Meeting last April, submit his resignation as National President of our organization. You should not be surprised that I, as your President, quickly found my way to a floor microphone to share how much our Branch had appreciated the work and attention which Gary had provided to the Association and to our Branch. He and his gracious wife, Marg, will be missed.

The main issue being discussed at the AMM, as well as at the Presidents' Forum which I attended, was the controversial 2016-2018 Strategic Plan. There was such resistance to this plan by the majority of Branches that the Plan was referred back to the National Board to describe a planning framework and define the related terminology. As a result, we should be hearing about more effective communication between the National Office and Branches.

In the meantime, the Dissolution of our Branch's Corporate status has been proceeding with new and revised By-Laws and the final Resolutions by Members to be presented in a Special Meeting prior to our lunch and speaker from 10:30 A.M. to 11:00 A.M. at Fort Calgary on September 25, 2015. We hope you will make a special effort to attend. While you are

there, you may wish to take time after the luncheon to see Fort Calgary's new sculpture "Mountie on Horseback" which is situated at the eastern edge of the Elbow River Traverse.

BRANCH EVENTS: Notice of Special General Meetings - Calgary and District Branch

Two Special General Meetings are being scheduled to coincide with our fall and winter quarterly Luncheons on Sept 25, 2015 and November 20, 2015 respectively.

As we have been discussing with members the past six months, our Branch is taking steps to comply with a resolution passed at the National Association's Annual Meeting in June 2014. It requires the current six incorporated Branches to dissolve their corporate status and return to their Branch Charter status. We are one of the six incorporated Branches.

FSNA Calgary Branch was founded on December 31, 1964 when it was awarded a charter by the National Association. In 2007 our Branch became incorporated under the Alberta Societies Act. The intent was to allow the Branch greater flexibility to raise and/or borrow money to pursue the acquisition of a property to house our office and administrative records.

To proceed with returning to our charter status and dissolving our corporate status we will be asking members to vote on a series of motions at the September and November Special General meetings.

The purpose of the September meeting will be to pass a special resolution that will reactivate the original charter with a revised Branch name (National Association of Federal Retirees –Calgary and District Branch) and to function as an unincorporated part of the Association. Members will also be asked to pass a special resolution that will result in the adoption of new by-laws, and normal resolutions to elect/appoint a Board of Directors, and authorize funding transfers from the current corporate bank accounts to the new Branch unincorporated bank accounts.

The November meeting will deal with special resolutions to dissolve and wind down the corporation.

The intent is to make this a seamless transition so that members will not see any impact on their membership and benefits either nationally or at the Branch level.

2015 Volunteer Recognition Awards

The Calgary and District Branch was awarded the Member Support Award.

Long-term care insurance gets a wake-up call, Will Ashworth 28 Aug 2015 (Life Health Professional)

A new survey provides overwhelming evidence that Canadians are extremely concerned about the longterm care challenges seniors face and yet the insurance industry is doing little to ensure our aging population does so gracefully.

"It is certainly fitting that we're meeting in Charlottetown where our forefathers sowed the seeds of confederation," said Bob Nutbrown, a member of the PEI Nursing Home Association. "Caring for our seniors is one of the most important things we can do as a society, and according to this survey, Canadians want government to do more."

The Canadian Alliance for Long Term Care surveyed 1,000 Canadians in July about this subject. Ninetythree percent believe that the federal government should work with the provinces to ensure that Canadians have access to the same level and quality of long term care regardless of where they live in Canada.

That's an admirable thought but it's hardly realistic given our health care system is already stretched to the limits. Somebody's got to pay for long-term care but it's not likely that the government, federal or provincial, is going to come to the rescue of hard-working Canadians.

Thus, advisors and insurance carriers have an opportunity to play the knight in shining armour.

"It's been positioned as an elitist product [LTC insurance] where people mistakenly believe the premiums are going to be \$4,000 or more a month and that's not affordable. Advisors hear this stuff and don't want to go there," LTC expert Karen Henderson told LHP. "The fact of the matter is the product has become much more flexible, much more affordable, much more adaptable."

Henderson believes that advisors who educate themselves about how the product works and understand inside and out the differences between the policies offered by the handful of companies that sell LTC insurance will do right by their clients.

Unfortunately, carriers don't make it easy for advisors providing almost no marketing or product support for LTC insurance.

"Long-term care insurance is not being marketed today," said Henderson. "Since Sun Life dropped their specialist program a couple of years ago for the third time, nobody is selling LTC insurance."


