#### By-laws 8.1.2 Agenda, Mandatory Business

At every Branch Annual Meeting, the Members assembled shall:

a) Approve a record of proceedings of the last Branch Annual Meeting and any Special Branch Meetings;

b) Receive a report from the President concerning the activities of the Branch board since the previous meeting and outlining the plans and priorities for the current and following year;

c) Receive the reviewed financial records for the previous financial year;

d) Receive the budget for the current year and forecast for the next fiscal year [including the "reserve" funds for specific non-recurring expenses];

e) Give the Board of Directors the authority to appoint a reviewer for the current financial year. The auditor shall NOT be a member of the Branch board or executive;

f) Consider any proposals for amendment of the Branch bylaws, notice of which was included in the notice for the meeting.

g) Conduct elections for the Branch board;

h) Conduct other such business as may be properly brought before the meeting.

Connecting Seniors to Technology survey

The City of Surrey has launched a **survey** to gain insight on the experiences, capabilities and barriers that exist within the seniors' community when they (we) use technology or digital services.

Participating in the survey will give seniors (and their caregivers) the opportunity to express their level of comfort with technology and help shape the development of programs and resources that will support 'digital inclusion', increase community engagement and reduce social isolation. It will also elevate awareness and improve access to online resources that are already available for seniors.

## Surrey's Age Friendly Strategy

The Technology Survey feeds into Surrey's Age Friendly Strategy, which has been developed to provide "a clear path forward for ensuring Surrey's seniors are active and fully engaged". (How are they doing so far?) The Strategy focuses on four key outcomes:

- Safety, Health and Wellness aiming to ensure that seniors are active and engaged in their community and that practices are in place to combat isolation.
- Transportation and Mobility access to a range of safe, convenient and affordable transportation options for seniors.
- Home –access to affordable and appropriate housing and the support necessary to remain as independent as possible.
- "Building and Outdoor Spaces" access to public places, outdoor spaces and buildings that are designed to be welcoming, safe and accessible for seniors.

Surrey hosted the inaugural UWLM (United Way Lower Mainland) Provincial Healthy Aging Conference in 2017. The 3<sup>rd</sup> conference, the Provincial Summit on Aging, is coming up, April 26-29 in Richmond.

#### Summit on Aging

Check out <u>bc.healthyagingcore.ca</u> One session will focus on approaches other provinces and countries are taking to promote aging in place. e.g The Frome project in the U.K. where medical practitioners are practicing "social prescribing", connecting patients to community supports to improve health and wellbeing.
