-New President of Council of Senior Citizens Organizations BC (COSCO)

On Feb 11th, 2022, Leslie Gaudette was elected President of COSCO BC, the non-partisan seniors' advocacy group that represents 80,000 members in BC. Leslie is a long-time member of Fraser Valley West and served on the Branch Board as Health Benefits Officer and VP. In 2014, she was awarded the Association's "collaboration" award for her work establishing ties with COSCO and the Office of the Seniors' Advocate. In 2018, she became Federal Retirees' Advocacy Program Officer for BC/Yukon and was a

steady hand on the rudder as we negotiated the squalls of a snap (pandemic) election in BC in 2020 and federally in 2021. Leslie was a primary organizer of the provincial virtual townhalls that Federal Retirees co-hosted in partnership with COSCO during both elections.

Leslie brings to her new role the perspective and insight gained through her years working in health research and epidemiology (in Alberta and Ottawa) with a focus on cancer and chronic disease control. She plans to carry on as APO for another term as she learns the demands of her new role with COSCO, exemplifying the adage: if you want something done, you assign it to a busy person!

COSCO is affiliated with the National Pensioners' Association, which has a collective membership of 1 million across Canada. There are 65 organizations under the COSCO umbrella, including major affiliates such as the BC Federation of Retired Union Members (FORUM), the BC Retired Teachers' Association, the BC Old

Age Pensioners' Association, and the BC Government Retired Employees Association. COSCO liaises closely with many other organizations, including the Office of the Seniors' Advocate, the Council to Reduce Elder Abuse, and the BC Health Coalition. Federal Retirees is advocating for improvements to the Pensioners' Dental Services Plan

"The PDSP has not been meaningfully updated since it was created 20 years ago, and our message to the Treasury Board is simple: it's time," said Anthony Pizzino, Federal Retirees CEO. "Members have told us the PDSP has not kept up with the cost of services, with important medical advances or with the recently arbitrated improvements to the employee dental plan. Good oral health is essential to overall health and well-being, especially as one ages."

The results of a 2019 survey that sought members' views on the dental plan have been shared with Treasury Board and the PDSP Board. The need for dental plan improvements was also on the agenda during the Association's first meeting with the newly appointed president of the Treasury Board of Canada, Mona Fortier.

"It took years of hard advocacy to implement the PDSP," notes Pizzino. "And while I can't guarantee that we will gain needed coverage improvements to the PDSP quickly, I can guarantee that we're working hard to make those changes happen."

Any updates to the dental plan will be separate from the Public Service Health Care Plan renewal, which Federal Retirees is currently negotiating.
