Alex reported that we now have \$7,582.70 in our BMO account, \$8,292.39 in our KCU investment accounts & \$58.35 in Petty Cash, for a total of \$15,933.44 in Financial Assets. The KCU accounts include \$184.26 in interest & -\$3.00 in a maintenance service charge.

We received the 3rd quarter DDS payment of approx \$2,098.45 on 20 Oct 22. NAFR Finance has reviewed our spring AFM financial report & seemed happy with most of it, especially our Reserves Template. Suggested wording changes for the report have been incorporated in next year's draft report. When I completed the financial tables for 2021 (Annexes A & B) I did not include interest on our KCU accounts. I hope they will not force us to resubmit amended reports to our membership next spring, as the interest was included ini the KCU balance reported.

We had no "Excess Surplus Funds" in 2021.

Their main concern was that our reported BMO balance at year's end (straight from BMO's financial report) of \$6,721.14 did not match the CMR's chequing balance of \$7,269.86, a difference of \$548.73. I suggested the error was likely due to CMR entry errors on my part, but could not explain it. I will have to review last year's info, but as the CMR ledger has been closed I cannot make changes.

We are still waiting on word whether or not we need to resubmit with interest income.

c. Director Telephone Committee

Gloria reported that new lists have been distributed to the committee members and that everything is working well so far.

d. Director Welfare
