3. President's Report - Branch activities- highlights 2021:

Ian Spence

lan presented an overview of Branch activities in 2021.

"In the early days of 2021, 15 months ago now, everyone was focused on securing access to vaccines and tippy-toeing through whatever wave of Covid we were in at the time. Many of us, thankfully, have been untouched directly, but for some of us the pandemic has reached in and torn at the hearts of our families. Our sympathies are with those who have struggled with the illness or lost loved ones.

"In our attempt to keep the lights on at the branch level, we continued the series of monthly Zoom chats we started in September 2020: and a series of presentations on "Personal Planning". Ilene Fika was a valued partner in learning how works, researching topics and presenters Zoom from COSCO's Health and Wellness institute, and managing and hosting presentations. I wouldn't say these events were wildly successful, attendance tended to average in the range of 12 to 20, but we felt it was important to offer members an opportunity to connect.

"The core work of the Association – advocacy – continued at all times at the national level and in the branches through Reach 338 – communicating our concerns and deepening our contacts with Members of Parliament.

"For National Public Service week 2021, the board decided to invest again – as we did in 2020 - in ¼ page advertisements in a number of the local weeklies. There are always questions about how effective these sorts of advertisements may be, but they are on small way of saying thank you to those who are on the front lines, serving Canada every day. The ads also help put the Association's brand to there in the public and the money supports local print media.

"As the summer was drawing to a close, there was an unscheduled (if long-anticipated) federal election. Branch volunteers swung into action with

Sept 8th an in-person Candidates forum – South Surrey/White Rock – in collaboration with

CARP. This was an outdoor event in Bakerview Park; we brought the tables and chairs

and the pop-up tents (they were threatening rain).

Sept 9th an in-person Candidates forum – Cloverdale Langley City, and

Sept 10th an in-person Candidates forum – Langley-Aldergrove.

These last two were organized in collaboration with Langley Seniors in Action, the Langley Retired Teachers Association, Triple A Senior Housing, Langley Senior Resources Society, Langley Meals on Wheels, Brookswood Seniors, and the Aldergrove Legion.

We also assisted in coordinating the province-wide virtual Election Townhall, held in collaboration with COSCO on September 13th. If nothing else, I am pretty sure the federal parties recognize the name of our organization and are familiar with our priorities.

"The branch board met regularly by Zoom throughout the year. On October 22nd, we held an in-person meeting and invited a number of members to join us for lunch, to say thank you for past contributions or to create an opportunity to meet potential volunteers. The event also served as a trial run for hosting in-person events under Public Health protocols.

"On November 17th, we also hosted a personal planning workshop organized around the You and Your Survivors workbook that Federal Retirees' offers its members. That was a combined in-person and virtual event and as organizers, we learned that we still have lots to learn about how to use Zoom successfully.

"We closed the year with a General Meeting and Christmas Buffet luncheon on December 9th. Even as we scrupulously observed Public Health protocols, we were happy to be in the company of old acquaintances and good friends, again. As we are today. Thank you for a good year. In particular, 'thank you' to Ilene and Leslie for all their help in organizing the election events. I don't foresee an election in 2022, but there will always be opportunities for volunteers to help us connect with our politicians and our communities. We have much to be grateful for and much to give. As we look at the state of the world today, we can all aspire to live by the adage: "If you have more than you need, build a longer table not a higher fence.""

5.1 Treasurer's Report:

This year the Branch moved its banking from CIBC to Van City Savings Credit Union. The move is now 100% complete and everything is operating well at Van City. Due to Covid, Branch activity and related spending was reduced in 2021 resulting in lower than historical expenditures and a higher savings balance. At year end the Net Assets of the Branch were \$39,780.71. On a related note the Board approved and has set aside funds in Branch Reserves in the amount of \$22,700 for a number of initiatives over the next few years including Recruitment and Communications, Volunteer Training & Development, Branch Advocacy, and small equipment purchases. For the year ending December 31, 2021, our Reviewer, Verna Sandison has reviewed our books and found them "Acceptable".

Stuart reviewed the Financial Statement for 2021, showing the Balances and the Earnings/Loss statement. He also presented for discussion the Reserves table (attached as **Appendices B,C, and D).**

5.2 Branch Reserves:

Proposed amendment to the Fraser Valley West Branch by-laws

lan Spence

Guidance from the national association has been evolving over the past three years on how branches should reserve funds for future projects without jeopardizing the Association's not-for-profit status. Before 2019, many branches, ours included, maintained "Defence of Benefits" reserves but the Association worried that Canada Revenue may question why dozens of branches across the country were holding separate reserves ostensibly for the same purpose. It was decided there should be one centrally-managed Defense of Benefits fund, and that branches could continue to "reserve" funds for various other non-recurring projects or anticipated future expenses. So, section 9.6 in our branch bylaws is out-of-date and the Association has suggested wording for an amendment which would leave it up to the branch board to create and change the reserves, with the only requirement being that the board present a report on the status of the reserves at each annual meeting.

However, we did not receive this new information in time to include the text of the proposed amendment in the Notice of Meeting for this meeting, so we will leave it to the new board to decide whether they want to adopt the proposed amendment on an interim basis and bring it for ratification at the Branch Annual Meeting in 2023.

The text of the proposed by-law change is included for your information.

Delete the current subsection 9.6 and paragraphs 9.6.1 and 9.6.2 as follows:

- 9.6 Defense of Benefits Emergency Reserve Fund
 The Branch may establish and maintain a reserve fund, known as the Defense of
 Benefits Reserve Fund, withdrawals from which may be made only to support
 initiatives to promote or protect significant pension or health benefits.
- 9.6.1 Maximum Amount

 The maximum amount to be held in the Defense of Benefits Reserve may be set at a

 Branch Annual Meeting by a proposal receiving a majority (50%+1) of the votes cast.
- 9.6.2 The Branch board may authorize the withdrawal from the reserve up to a limit set by a vote at a general meeting. Withdrawals over that limit must be authorized at a Branch Annual, Special or General meeting, by a proposal receiving a majority (50%+1) of the votes cast.

And substitute a new subsection 9.6, worded as follows:

9.6 Reserve funds — The branch may establish and maintain reserve funds in accordance with the Association's regulations. The branch board has the authority to create, change or remove such reserves and must present a report on the status of all branch reserves at each annual general meeting as part of the presentation of the branch's financial statements.

lan noted that it has been customary to assign signing authority to the directors holding the four executive positions but that for flexibility, with a number of directors having commitments and travel plans in the coming year, the board may wish to assign signing authority to up to two additional directors.
