ADVOCACY

As you are aware we are now into a Provincial Election. The pandemic does not allow us to meet with Party leaders and candidates in person. However, we will be moving our issues forward on behalf of you, our members.

On February 3, our Atlantic Director, Leonard Leblanc, will be hosting a Webinar Townhall meeting with Party Leaders. Matters of interest and concern to our members and all seniors will be put forward at that time. At the National and Branch levels, our advocacy efforts have been strong over the past year despite the pandemic restrictions.

BUDGET

For the Fiscal Year 2020 ending in December, our Branch recorded an operating surplus due to decreased expenditures as a result of the COVID-19 pandemic. We have attached documents (see link in email) which will give you an overview of our Branch fiscal position for the year ending December 31, 2020. The Board has approved the transfer of \$7500.00 from our Branch Defense of Benefits fund to the National Defense of Benefits fund, along with an additional \$2500.00 Branch surplus funds for a total of \$10,000.00. Our Branch is in a very strong and stable financial position going into 2021.
