
## Seniors Advocate: Make Home Support Services "Free" to save \$\$, reduce pressures on ERs, Long -Term Care and Family Caregivers

At the end of February, the Seniors Advocate for BC issued a report calling for a restructuring of home support services for seniors. Ms. Mackenzie noted, "The majority of provinces do not charge for home support services. B.C. does charge and is the most expensive." For example, a single senior with an annual income of \$29,000, must pay \$9,000 a year for a one-hour daily visit of home support. As a result, people who could manage at home with a relatively minor level of support either do not access the support they need, adding to the stress of family caregivers, or they go into long-term care sooner than they otherwise would have had to. The report says, "B.C.'s rate of newly admitted long-term care residents with low care needs is twice as high as Alberta and Ontario who do not charge for home support and is 34% higher than the national average."



A long-term care bed for a senior with a \$29,000 annual income costs the government \$60,000 per

year; providing one hour of home care per day would cost \$14,000. "We must recognize the cost barrier to home support is causing pressures in other parts of the system as we see increased wait times for long-term care and crowding in emergency rooms," Ms. Mackenzie said. In addition to eliminating the financial barrier to home support services, she noted a need to 'modernize care plans', pointing out that "almost one third of home support clients need additional services such as housekeeping, meal preparation and laundry..." "There was a major shift in the 1990's when housekeeping, laundry and meal preparation were formally removed as routine home support services. Over the last decade, there appears to be an informal drift



to eliminating more and more services and an increased reliance on family members. The current approach fails to capture the daily changing needs of home support clients..."

Branch volunteers are at work spreading the home care message. We took the opportunity to speak with Shirley Bond, Shadow Cabinet minister for Health, Seniors and Long-Term Care at a coffee

meeting hosted by Surrey-White Rock MLA Trevor Halford on April 21st met and we have scheduled meetings with Fraser Health leaders. Take the time to read the Advocate's report:



## As the century turned....

George recalls that one big challenge gripping the national board in those days was the project of digitizing membership records; like (it seems) every IT project, it became controversial as costs blew past initial estimates.

George continues to follow Federal Retirees news and regrets that his health didn't allow him to join the conga line at the Branch's 60<sup>th</sup> anniversary celebration. George and Catherine were married for 59 years, until her death in 2015. He has three children, four grandchildren and two great-grandchildren, and looks forward to their visits on the weekends.
