In addition, the National President, Roy Goodall, and CEO, Anthony Pizzino, spoke to the group and provided information on the general operation of NAFR and what is front and center on their agenda. One important message from National was for all members to ensure they have provided information to Canada Life as the new service provider of the PSHCP.

Other activities included an Advocacy workshop, a discussion on long term care initiatives in Nova Scotia, a review of proposals for the AMM in Ottawa/ Gatineau, branch funding and presentations from candidates running for Atlantic District positions on the National Board.

The Branch had its annual Marystown meeting in June and while it was better attended than last year, there is still work to be done in getting members out.

Along with the administrative aspects of the agenda, such as approval of previous minutes and a financial report, there were discussions on the impact of the PSHCP Plan moving to Canada Life on July 1 and the processes of enrolment.
