"Aging in Place" panel discussion draws a crowd

Panelists included representatives from Fraser Health's Seniors, Community and Complex Care section, the United Way (funds the Better At Home program), Brella Community Services (delivers the Better At Home program in Surrey/White Rock), and the Semiahmoo Seniors Planning Table. The aim was to highlight the support services that are available to help older adults to "age in place" in their homes and communities.

To guide the discussion, we used the example of "Alice", an 83 year old woman living on a low income on her own in a condo in White Rock; she has begun to exhibit some signs of 'frailty'. How would Alice access 'the system' and how much support could she expect for medication supervision, bathing assistance, light housekeeping, laundry and meal preparation? Nicole Tait (Brella) told us that Alice might need to be

"open" to alternative ways of getting the assistance she needs.

For example, neither Brella nor Fraser Health offer assistance with in-home meal preparation, but there are affordable meal delivery programs that Alice could access. Brella offers light housekeeping and laundry services but only for two hours a month. Assistance with bathing may be available to Alice once a week through either Fraser Health or Brella. Additional assistance may be available in connection with adult day programs in some communities (e.g. Langley).

We also discussed the case of "Vick and Jane", married 60 years, with a household income of \$75,000 a year, derived mostly from Vick's workplace pensions. If Vick has to go into Long Term Care, which takes 80% of his income, what happens to Jane? Pension income splitting was one option that might allow Jane to remain in the family home when Vick goes into care.

Heather Martin spoke on "20 questions to ask" when engaging private home care services to supplement the services available through the public agencies.

A key message that emerged from the discussion was **do not wait to plan**. Research your options and prepare your own personal strategy for 'aging in

place', so that you know where to turn when you do need help, and you can address problems quickly before they get out of control. We hope audience members went away with at least a clearer idea of what their home care options are.
