

B.C. Health Minister announces appointment of new seniors' advocate

B.C. Health Minister Adrian Dix says the province's new seniors' advocate is Dan Levitt, an adjunct professor of gerontology at Simon Fraser University and the head of a non-profit long-term care home.

Levitt says he's "deeply honoured" to be appointed the province's second seniors' advocate, and thanked current advocate Isobel Mackenzie, who is retiring in April.

The health minister said that Levitt had championed the rights of seniors for three decades, and the government would work with the advocate to improve seniors' lives.

According to the B.C. government, the seniors' advocate "acts in the interest of seniors and their caregivers," by monitoring care and supports for seniors provided by the province and private industry, and producing regular reports and recommendations on how they are functioning.

Levitt said the demographic shift as the population ages means it's important to start "rethinking aging" and no longer view it as something to fear but something to embrace.

Levitt says his first priority will be travelling the province to meet seniors in rural and urban centres to hear their concerns and produce reports on how to improve their lives. With B.C.'s population rapidly growing and aging, the health minister said the Office of the Seniors' Advocate is becoming more important than ever to ensure a more accessible, transparent and accountable approach to seniors' care in B.C..

Levitt said he wants to address a societal narrative that sees "aging as a negative thing," leading to an unwarranted "fear of older people."

"There's a fear of growing old and I think if we turn that upside down and we rethink it, we embrace it and we think about longevity as a good thing, I think that's a much more healthy approach," he said.

The Pacific Regional Centre for Healthy Aging (PRCHA) is a network in British Columbia that promotes healthy aging by working with the public and the health care community. The PRCHA uses the <u>AVOID Frailty framework</u>, a strategy developed by the Canadian Frailty Network.

AVOID stands for Activity, Vaccination, Optimize medication, Interaction, and $\bf Diet.$

The network offers healthy aging assessments, peer coaching (older adults helping other older adults), webinars, a listing of local community services, and other programs for older adults, care partners, peers, health care professionals, and researchers.

The PRCHA promotes social prescribing, where health care providers connect patients to community resources to improve their health and well being. Social prescribing is a collaborative, holistic approach that recognizes that not all health supports need to be medical.

As well, the PRCHA runs innovative pilot programs, carries out research, and advocates for healthy aging.

The network is a joint effort [link to Partner page] between regional health authorities, universities, and community organizations in B.C. It is funded by the Canadian Frailty Network.

Advocacy update

Branch volunteers continue to meet with local MPs to press the recommendations contained in Federal Retirees submission to the parliamentary Finance Committee, in advance of the 2024 Federal Budget.

Ian Spence and Don McKay (member and constituent) met with MP Ken Hardie (Liberal, Fleetwood-Port Kells) by Zoom on January 13th. (Plans to meet in-person were scuttled by weather.) During the meeting we reiterated Federal Retirees' recommendations for the 2024 budget, which include measures to support implementation of standards for long term care and improved home care services and supports for caregivers, including increasing the value of the Canada Caregiver Tax Credit by making it refundable. Don McKay raised the issue that value of the CPP Supplementary Death Benefit has remain unchanged for decades.

BC 04 volunteers (L to R) Ian Spence, Bernd Hirsekorn, Leslie Gaudette and Judy McLellan met with South Surrey White Rock MP the Hon. Kerry-Lynne Findlay (centre) on January 25th. Ms. Findlay outlined some of the CPC's ideas on improving access to health care, such as a mentorship or apprenticeship program that would allow health care professionals trained outside of Canada to practice under supervision while they worked toward Canadian accreditation. Ms. Findlay noted that a national seniors' strategy comprises a range of issues that will require improved dialogue between the federal government and the provinces, and she hopes the election of a Conservative government will be the opportunity for a 'reset' in federal-provincial relations.
