- 6. Annual Report
 - a) Guy reviewed the 2023 Annual Report with a few highlights from an unusual year with raging forest fires. 2024 Annual Report Central Okanagan Branch BC07

Make a Difference through Advocacy & Connections

As we look back over 2024, public attention to forest fires, water supply, the economy or inflation eventually led to heightened focus on politics and leadership at the provincial, federal and international level. Focusing on two key areas of advocacy role and creating connections, 2024 may be leading us to new ways to support and represent our members.

Shift for Advocacy - One of our primary roles in the Branch is to advocate for our members' needs and services with elected officials at both the provincial and federal level. At the provincial level, for example, this was complicated by changes in ridings along with the BC United and BC Conservative Party leaders adding sufficient confusion about who is in the candidate pool. As a result, our conversations at the board level, and with other branches at the Eastern BC Conference in spring prompted us to think about our future strategy could or should be for advocacy during elections.

We can no longer lean on practices of the past in the changing political landscape – townhalls have turned into webinars; events are now considered in light of safety concerns for our members as well as elected officials; and riding changes don't necessarily line up with the areas we represent as the Central Okanagan Branch. Our time and effort is best served by focusing on connecting with elected officials rather than candidates. In summer, we had MP Tracey Gray attend our annual summer picnic at Mission Creek Park with a surprise in her support staff.

With a federal election in spring 2025, and a new US President drawing more from our elected officials, it may more difficult to arrange branch specific activities around advocacy. Our members are also focussed on understanding, deciding, and demonstrating who we are as Canadians to the world at large. We need your input and ideas on how to evolve our advocacy role at the branch and national Association level so that we continue to be heard at the highest levels of our provincial and federal governments.

Expanding our Connections - Our Branch focus on creating connections continued in 2024. We connected through monthly coffee meetings, publishing two editions of the OK Central Newsletter, and answering member questions via phone and email. The BC/Yukon District training conference and the Eastern BC meeting provided excellent opportunities

to connect with other branches, and give input into the National strategic plan. We also collaborated with RCMP Veterans and BC Retired Teachers Association for Learning Experiences and plan to expand connections with North and South Okanagan Branches and other retiree organizations. In June, for example, Central and South Okanagan presidents attended the PIPSC Executive Union conference in Kelowna to raise awareness about our Association. We will continue to connect to other organizations and hopefully partner with more to deliver new learning experiences in 2025.

The Medwatch program that thrives at Summerwood Retirement resort was introduced to the Westwood Retirement Resort with updates made to the form. The Salvation Army Kettle campaign was also successful with volunteer teams gathering donations in both Kelowna and West Kelowna in November and the Branch was recognized by the Salvation Army with a certificate of appreciation.

2024 ended with over 60 people enjoying a Christmas luncheon of good food, conversation and entertainment. Because of the fall election, planning began in 2024 to host a learning experience in estate readiness for early 2025.

We wanted to make the best use of the monies that come to the Branch. We completed our plan to replace outdated equipment so that our Board can be more efficient as well as subsidizing recruitment and member events such as the Summer Picnic in Mission Park, the Christmas Luncheon and the AGM at the Lakeview Heights Church.

So what about 2025? We are going to try new approaches on how to reach our elected officials and stay connected in the community. Attending community events as branch representatives, inviting other associations to partner with us to create learning experiences or info sessions, and working with North and South Okanagan branches will be emphasized.

Our volunteers and members' involvement will be key to a successful new year in our Branch. It matters that we can continue to be of service and thank you for your support in the challenging times that are ahead. Please help us do so by keeping connected to the Board and to each other.
