- Sound knowledge of relevant information technology and associated analytics, including marketing platforms such as Click Dimensions, CRM, social media and content management systems
- Knowledge of Canadian Anti-Spam Legislation (CASL), EU General Data Protection Regulation (GDPR), Quebec Law 25
- Good communication skills, excellent English and French language ability (of publication standard).
- Demonstrated ability to work effectively with a variety of stakeholders and to work collaboratively as part of a team.

- A high level of diplomacy and persuasion to work with volunteers to encourage compliance with Association communications practices and to adhere to published service standards.
- Proactive approach to meeting deadlines and delivering results with limited supervision.
- Flexibility, creativity and effectiveness in working collaboratively.
- Ability to work independently and as part of a team.
- Ability to motivate and oversee a team of volunteers to perform precise and timely work.
- Ability to maintain professional demeanor and perform calmly in stressful situations.
- Ability to deal with discretion on sensitive issues and to respond positively to challenges.
