## 5. COMMITTEE REPORTS

## a. VP Membership

Hugh reported the current membership numbers:

### b. Treasurer

Alex reported that as of 12 Nov 25 we have \$4,755.58 in BMO, \$9,330.25 in the KCU, \$57.97 in petty cash, and \$25 in KCU shares (5 x \$5.00) for a total of \$14,168.80 in financial assets.

The Fall General Meeting on 21 Oct 25 cost \$1,332.50, \$332.50 over budget. This was due to higher hall rental fees (up \$56.50 from the spring) & food costs. In next year's 2026 budget he will budget \$1,500 each for the spring & fall meetings, \$2,500 for the BBQ & \$4,500 for the Christmas Luncheon.
