Karen advised that the Branch has purchased a laptop computer, authority for this purchase was approved in 2016 when 2 computers were approved and only one purchased. In addition, a projector was purchased. This equipment will be used at meetings and at recruitment presentations.

Proposed Branch By Law changes

Karen informed members that at the February AGM we will be proposing a change to our by laws regarding reserved funds. Lorraine Casey explained that the current by law on reserve funds is too restrictive in its use, and therefore, we intend to introduce a new by law which will permit us to use these reserve funds in our priority areas. This will be further explained and brought up for a motion in February.

Membership Fee Increase

Karen advised that effective January membership fees increased 2.2% to Annual/Monthly rates of Single \$51.36/\$4.28 and Double \$66.60/\$5.55.

Request for Funds

Karen informed members that the Board received a request from the Sunny Brae Legion for a contribution to their fund to pave their parking lot. Board members voted not to support this request and Karen responded on behalf of the Branch.
